## **Processing suggestions:**

- Thoroughly agitate polyol (hardener) component to be sure the liquid is homogeneous.
- Properly weigh out the appropriate amounts of resin and hardener.
  - Mix thoroughly for two minutes being sure to scrape sides and bottom of container.
  - o For best results, de-air the product before pouring into mold.
  - o Pressurize mold in a pressure pot at 60psi until cured.
